

# Montclair Dog Club Liability Waiver & Agreement

This agreement outlines the terms and conditions for pet owners utilizing the services provided by Montclair Dog Club. By signing this waiver, you acknowledge and agree to the following:

## 1. General Liability Waiver

I understand and agree that Montclair Dog Club and its employees will exercise reasonable care for the safety and well-being of my dog(s). However, I acknowledge that Montclair Dog Club is not responsible for any injuries, illness, or death that may occur while my dog(s) is/are in their care, including, but not limited to, dog-to-dog interactions, injuries resulting from outdoor activities, and exposure to other dogs or environmental factors.

- I agree to waive any claims against Montclair Dog Club, its owners, employees, or agents for any injury, illness, or harm that may occur while my dog(s) is/are under their supervision.

## 2. Emergency Veterinary Care

In the event of a medical emergency involving my dog(s), I authorize Montclair Dog Club to seek veterinary care as they deem necessary. I understand that all reasonable efforts will be made to contact me or my emergency contact first.

- I agree to be responsible for all veterinary expenses incurred during such an emergency, including transportation costs.
- Montclair Dog Club will not be held liable for any outcome resulting from emergency medical care.

## 3. Health & Vaccination Requirements

I confirm that my dog(s) is/are in good health and have received all necessary vaccinations, including rabies, distemper, parvovirus, and bordetella.

- I have provided or will provide proof of up-to-date vaccinations.

- I agree to inform Montclair Dog Club of any health issues, including allergies, ongoing medical treatments, or recent illnesses.
- I understand that Montclair Dog Club reserves the right to refuse service to any dog(s) that shows signs of illness or poses a risk to other pets.

## 4. Behavioral Waiver

- In the event of an incident, I agree to cover any damages or injury costs caused by my dog(s) to other animals, property, or staff members.

## 5. Sleep and Activity Preferences

I acknowledge that I have provided accurate information about my dog's preferences, such as sleeping arrangements, feeding schedules, and exercise routines.

- Montclair Dog Club will make all reasonable efforts to follow my instructions for my dog's care but will not be held liable for deviations resulting from unforeseen circumstances.

## 6. Photo & Video Release

I grant Montclair Dog Club permission to take photos or videos of my dog(s) during their stay for promotional and social media purposes.

- I understand that no personal details will be disclosed in any materials shared.

## 7. Payment & Cancellations

I agree to pay the full amount for services rendered according to Montclair Dog Club's pricing and policies.

- I understand that cancellations must be made 24 hours in advance for daycare services and 48 hours in advance for overnight boarding to avoid being charged the full fee.
